The undersigned does hereby state they are 21 years of age or older and that they have been informed about, and provided with a copy of the NYC Administrative law in regards to the transport and possession of a Marker In the 5 boroughs of New York City.

SECTION 10-131 B OF THE NYC ADMINISTRATIVE CODE

b. Air pistols and air rifles; selling or possessing. 1. It shall be unlawful for any person to sell, offer to sell or have in such person's possession any air pistol or air rifle or similar instrument in which the propelling force is a spring or air, except that the sale of such instruments if accompanied by delivery to a point without the city, and possession for such purpose, shall not be unlawful if such person shall have secured an annual license from the police commissioner of the city authorizing such sale and possession. The sale and delivery of such instruments within the city from one licensee to another licensee, and the use of such instruments in connection with an amusement licensed by the department of consumer affairs or at rifle or pistol ranges duly authorized by law shall not be considered a violation of this subdivision.

The undersigned further warrants that if they so chose to risk transporting a marker after having read the administrative code, that they do so at their own risk and agree to hold NYC Paintball Inc. harmless and clear from any responsibility for any consequences which may arise from the transport of the marker within NYC. They further warrant that they shall not hold NYC Paintball responsible for any legal consequences such as seizure of their equipment, receiving a ticket or charge, or arrest as a result of such transport.

This Waiver must be faxed to 718-361-8343 or 8340 7 days prior to your reservation. Hold on to the original waiver as you will need to present it at the door on the day of your reservation. Failure to bring the original will void your use of the marker. If any member of a group is under the age of 21 then the marker will only be allowed if transported by an adult 21 years or older and the waiver must be signed by the individual transporting the marker.

I agree to transport my marker in a fashion which would make it impossible to fire under any circumstance. This means the marker will be broken down. The barrel will be off, the air tank will be unscrewed from the marker body and the air tank will be empty of any compressed air. The marker and its components will be stored in an opaque bag which will preferably have a lock. The marker shall never be exposed in public during transport.

NYC Paintball does not imply in any way that transporting a marker is legal. The above transport guidelines have been implemented for the protection of the player and the public.
